The undersigned (skipper/parent/guardian) furthermore agrees that the officers, governors, committee members and personnel of the Frostbite Yacht Club Connecticut River Squadron and the Essex Yacht Club are not to be held responsible for any accidents, damage or injury to property (personal or otherwise) boats, crew or guests arising from any incidents caused during or related to any race or activity associated with the Frostbite Yacht Club Connecticut River Squadron racing series and further agrees to indemnify and hold harmless each of the officers, committee members, governors, and personnel from any liability, claim or expense (including attorney's fees) against any or all of these persons.

The undersigned (skipper/parent/guardian) furthermore agrees to be bound by the Racing Rules of Sailing, as adopted by the U.S. Sailing Association, including U.S. Sailing prescriptions when they apply, as well as, the rules of each class concerned, and other such rules as are applicable.
